Project: POLARIS – Professional Online Licensing and Regulatory Information System

Description: The Professional Online Licensing and Regulatory Information System Project (formerly known as Business and Technology Modernization Rollout 3 (BTM R3)) is a continuation of the DOL's Business and Technology Modernization initiative. DOL launched Rollout 1 of DRIVES for vehicles in December of 2016 and Rollout 2 of DRIVES for drive licenses in September of 2018. POLARIS Release 1 went live in November 2019. At completion, POLARIS replaces the legacy business and professional licensing and regulatory systems with a Salesforce/BasicGov Platform-as-a-Service (PAAS) solution, hosted by Salesforce and supported by Deloitte. POLARIS improves the business climate by facilitating easier access for consumers and licensees, and provides DOL staff and licensees with an easy to use, cost-effective, reliable and sustainable system.
