## Policy/Standard Review – Policy 113, 113.10, 113.30, 113.40 – Technology Business Management

Derek Puckett introduced WaTech's new enterprise technology manager, Samantha "Sam" Zee. Sam provided an overview of the governance and review process that these policies and standards went through prior to this subcommittee meeting. Cammy Webster, TBM program manager, discussed the content and future strategy for these policies and standards. The TSB members at this meeting agreed to recommend to the full board to approve an extension of the sunset date, understanding that there may be further changes in the future, especially as we integrate with One Washington.

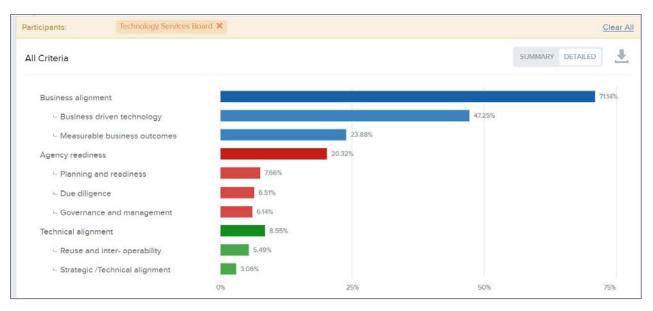
## **Decision Package Scoring Criteria Weights – Results**

Cammy reviewed the final results from the Decision Package (DP) Scoring Criteria Weighting Exercise from the September full board meeting and how the TSB's results aligned with the aggregated results from all four groups that participated in the exercise. These weights are being used to score over 120 DPs. She also noted that WaTech consulted with over 30 agencies regarding their decision packages with a focus on strategic plan and IT modernization.
